

**PERSONAL APPEARANCE RELEASE**

**MINOR RELEASE – FOR INDIVIDUALS UNDER 18 YEARS OF AGE ONLY**

1. **Grants of Rights:** I, \_\_\_\_\_, Parent / Guardian of \_\_\_\_\_, a minor child (“Minor”), hereby grant to MPH Entertainment, Inc., its licensees and assigns (“MPH”), the following rights: to interview me and Minor; to take motion and still pictures of me and Minor and recordings of my and Minor’s voice; to use and distribute the pictures, recordings, my name and information which I or Minor provide in any and all media now known or hereafter invented, devised, or discovered, in perpetuity, throughout the world, including without limitation in (a) the television series presently entitled “**The Dog Whisperer with Cesar Millan**” (the “Program”), (b) exploitation of the Program or any portion of the Program in any and all media, (c) d) in advertisements, publicity, marketing, merchandising, and promotions for the Program and/or Cesar Millan or his dog psychology and training techniques (the “Advertisements”), and (e) editing the Program, pictures, recordings and Advertisements in any manner which MPH elects in its sole discretion.

3. **Consideration:** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I grant the rights set forth in Paragraph 1 above.

4. **Release:** I agree that I hereby voluntarily waive any right I or my heirs or successors may have to sue MPH or any person or company related to the Program or the Advertisements for reasons including but not limited to: (1) MPH, its licensees and assigns did not take or use in the Program all or any portion of the pictures, recordings, my name or information given by me; or (2) I do not approve of the manner in which MPH, its licensees and assigns took or used in the Program the pictures, recordings, my name or information given by me or Minor..

5. **Entire Release:** In signing this Release, I have not relied on any representations or other statements that are not contained in this Release. I further agree that no oral agreements are binding on MPH unless reduced to writing and signed by a duly authorized officer of MPH.

6. **Other:** I represent and warrant that I have the full right, power and authority to grant the rights herein granted. Under penalty of perjury I certify that the information and representations given or made by me and Minor that are contained on this form are correct. This Release shall be performed at least in part in California whose law shall govern and whose courts shall have exclusive jurisdiction over any dispute relating to this Release. I understand that upon my execution of this Release, a duly authorized officer of MPH will counter-execute this Release, and return a copy to me.
